#### Land Acknowledgement

## **Resignations/Changes:**

- 1. Laura Barnes, resigned May 3 after volunteering for 3 years. Her contributions include the compilation and compression of 31 eduDANCEon! Resources for educators to use in their blended classrooms during COVID, and the building of a website, ossdancefest.ca.
- 2. Deb Kapp is moving to the Sub-Committee, Advocacy and Inclusion.
- 3. Melissa Chiandussi is resigning.

# Successes in 2022-2023

- 1. The development of Sub-Committees to engage with our volunteers more effectively.
- 2. A proposal to CODE to share the finances for a joint project with OSSDF that includes creating a Dance Advocacy video/documentary was accepted by CODE.
- 3.\* An article about OSSDF was published in the Provocations Journal, volume 2: *Holding Space and Bearing Witness through Drama and Dance*. This collection is a rich offering of drama and dance education to our community of teachers, artist-educators, arts advocates, and students.
- 4.\* A detailed resource for our OSSDF Adjudicators and Scoring Coordinators was created with plans for an OSSDF Event Manual to be written.
- 5. This year, we sent out a survey after OSSDF2023. 11/16 teachers completed the survey and also attended a Follow-Up Meeting on Wednesday, May 31st to hear the suggestions and comments that were shared. This was a great success and the first time we had a strong representation after an annual event. Recommendation is to review the comments again prior to planning the 2024 event.
- 6. Katie Knowlton is very tech savvy we were fortunate to have her expertise to communicate event information to teachers and social media during the event.
- 7. Personally, I am grateful and proud to have been a member of this team of board members. Thank you to our new and experienced members whose comradery and

commitment to assist in the planning for the return to a LIVE DANCEFEST so enjoyable. A new venue, lower funds and cancellations were challenging; however, your support of decisions made were understood and greatly appreciated. Thank you too to those people who stepped up to assist our board members (you know who you are) and now, I'm very pleased, will be taking a larger role as we move forward.

#### Disappointments in 2022-2013

- 1. UWBlueprint.org was problematic this year. Information that we had in the past, was not present on the adjudication platform, ie., Awards, Notes, numbering of dance entries as well as some filters. Furthermore, due to a lack of communication from Blueprint to update us that our website host was now going to have a further cost attached, we lost all the data from our prior events. They attempted to replace/fix our platform; however, although we thought it was corrected, we discovered that it was not usable for our event and last minute, the adjudicators had to use the old method of paper and pen for scores and award considerations.
- 2. We were unable to update the website to our expectations and social media was lacking. Communication was not always as we hoped. DANCEBLASTS were lost.
- 3. OSSDF2023 experienced a financial loss due to withdrawals of schools, participants, dance entries and accommodations.
- 4. We were unsuccessful with a regional arts grant application.
- 5. Lack of meeting time commitments accounted for an unstable budget. Next year, due dates must be earlier to plan a smoother event with more opportunity to review music, Accommodations, meal assignments, event schedule, workshop volunteers, and other details with time to actually have an event meeting two days prior with all things accounted for.

## **OSSDF BOARD MEETINGS**

Volunteer members met on ZOOM the last Wednesday of each month to respond to the needs presented by dance educators at monthly Teachers Council Meetings. TC Convenor, Joanna Perlus, brought the concerns of this grassroots group to the Board to learn their needs. The members planned for the provision of resources, workshops or lectures to support the Ontario educators. The other focus was to organize and plan the annual DANCEFEST2023.

Moving forward, I am suggesting that **Board meetings for 2023-2024** have executive members meeting once a month, prior to the monthly meetings with all Board members. This will shorten the Board meetings for all members. Katie and the executive will determine dates, times and the focus of meetings at a future date this summer.

# **TEACHERS COUNCIL MEETINGS**

The monthly Teachers' Council Meeting on ZOOM is an OSSDF initiative, **eduDANCEon!** Networking & Professional Development was created to support our provincial dance educators. It is a wonderful opportunity to meet other teachers in a non-threatening environment. Furthermore, this connection removes that "island" feeling that many feel as the only dance teacher in their school. Also, members have access to our 31 **eduDANCEon!** Virtual Dance workshops to use in their classrooms or access the lesson plans that are included. **Observation:** Numbers have dwindled. We had greater attendance during Covid when the Board met every two weeks to respond to concerns. The Teachers' Council is an important grassroots group; however, it may be useful to send out a survey to inquire their feedback regarding what topics they would like OSSDF to focus on that will be a support for 2023-24. Furthermore, maybe fewer meetings are needed. The first meeting in September will be when teachers can share their input or email their feedback to Joanna Perlus at ossdfteachers@gmail.com

**Teacher Council meeting dates, times and topics of interest** will be decided by TC convenor, Joanna Perlus, and the attending educators in September and a schedule created. Feedback will be shared for the Board to respond to. Joanna provides support, safe discussion and/or education to attending teachers. This partners well with her position as Dance Liaison on the Council of Ontario Drama and Dance Educators - CODE. She welcomes everyone with her warmth, enthusiasm and energy to this friendly gathering.

<u>Website</u>- we need help with this. We do not have any financial means to hire someone. We will do our best to chip away at this task until we have someone who is interested in providing us with support.

### OVERVIEW of 2022/2023

<u>Adjudicators</u> - Edward Duranyi was replaced by Shelley Kenney one week prior to the event. Shelley was great and will return as a lead for the 3 adjudicators next year (2 dance artists and an educator) who will be: Shelley Kenney, Shawn Byfield and Deb Kapp. Feedback for teachers and students will be sent out later this week.

<u>Music</u> - This is still an issue. Some schools are not removing inappropriate references in the content. Please review carefully all music for dance entries before submission.

<u>Workshops</u> - Personally, I loved the variety of workshops organized by Meghan and Katie. Positive comments were heard from students who felt represented by the diversity that was offered. I was very pleased with the Indigenous workshop sponsored by Cathy Bowman and I and that Robyn Michaud is interested in more involvement with OSSDF, maybe with the Advocacy and Inclusion Sub-Committee. I'm looking forward to more conversation with her.

I did not feel it appropriate to ask Shelley Kenney to cover both the adjudications and Edward Duranyi's workshop with only one week's notice. Therefore, I was very pleased to receive a positive response from Shawn Byfield to cover his Auditions Workshop which was highly received. Also, the Inter/Adv Contemporary workshop needed to be covered at very short notice due to a family emergency. Laura Dufour was awesome and covered the workshop with 5 hours notice. The comments from the dancers were very positive. That said, I recommend asking Jeff Wong again to attend next year.

Responses from workshops offered at OSSDF2023 will be reviewed before making considerations for OSSDF2024. That said, we wish to continue to offer the variety and diversity of workshops and workshop leaders.

<u>Awards and OSSDF2023 certificates</u> - have all been mailed out and/or delivered. Awards for 2024 will need to be reassessed by the board.

Note: We have made it a practice to 'share the wealth' with awards. Every school has always gone home with an award. This year, we missed giving a Special Award to Forest Heights C.I. and Pain Court. That needs to be rectified for the future.

Today, we discovered that we missed sending out one Special Award to a St. Anne student. I will sent it out asap with apologies.

**<u>Retail</u>** - Civilian was a great supplier. It was an easy process and limited effort for the Board but the opportunity to purchase was staggered before and after the event which was confusing for some people, including me. OSSDF also didn't make as much money as we hoped but maybe that's the trade off. We will investigate with the people at Civilian regarding other retail items and to see if there are other means of selling OSSDF merchandise.

<u>Venue</u> - this was our first time hosting at University of Waterloo. We will return next year. However, issues encountered this year will be reviewed at follow-up meetings with Janelle Rainville, Theatre Manager and Susanne Keppler, Conference Manager.

Melissa Chiandussi informed today that UW is offering refund for Thursday night accommodations but not Friday night.

The venue for OSSDF 2026 - 2027 may be Laurier University. Closer dorm accommodations and 8 large workshops areas (with mirrors) are appealing.

I look forward to continuing this important work as your Past-President, by providing mentorship and support to the new Board.
