The business discussed at the 2022 AGM related mainly to the Appointment of Directors for 2023-2024, Approval of financial statements, By-Law Resolution #2 setting that at least 50% of Directors must be current or retired teachers certified by the Ontario College of Teachers, DANCEFEST 2023, creation of new sub-committees, and the Teachers' Council. Motion to approve by Joanna Perlus; seconded by Katie Knowlton; carried.

Approval of Financial Statements for the year ended August 31, 2023

The Financial Statements for the Year Ended August 31, 2023 were presented. Cathy Bowman reported that we had a small loss on our first post-COVID Live event, which increased our accumulated deficit. Motion to approve by Laurel Brown; seconded by Meghan Kidd; carried.

Resolution No. 2 was presented to amend the composition of the Board.

Be it resolved that the ONTARIO SECONDARY SCHOOL DANCEFEST Members hereby:

- 1. Require that a minimum of Fifty Per Cent (50%) of Directors be certified by the Ontario College of Teachers
- 2. Allow that the Directors in #1 be either active or retired.
